Prof. Richard Dull, Ph.D.

Richard Benbow Dull, Ph.D., CPA/CFF, CFE, CISA is the GoMart Professor in Accounting Information Systems in the Department of Accounting in the College of Business and Economics at West Virginia University. Dr. Dull holds a BBA (Accounting) and a BS (Computer Applications) from Harding University, an MBA (Accounting) from University of North Carolina at Greensboro, and his Ph.D. (Accounting Information Systems) from Virginia Tech (all USA based institutions).

Dr. Dull's research interests include using technology to improve decision making, as well as business analytics, continuous assurance/monitoring, and effective accounting education. His research has been published in academic and practitioner journals, including Journal of Information Systems, International Journal of Accounting Information Systems, Journal of Emerging Technologies in Accounting, Research in Accounting Regulation, Accounting Education: An International Journal, Issues in Accounting Education, Journal of Accountancy, and CPA Journal. Dr. Dull is the co-author of two textbooks, *Accounting Information Systems (11th edition)*, and *Forensic Accounting and Fraud Examination: Knowledge, Skills and Abilities*. He has presented his research at a wide range of venues within the USA and internationally.

Currently, at West Virginia University, Dr. Dull teaches in the undergraduate accounting and graduate forensics programs. Each fall for the past five years he has also taught a compressed, graduate forensic accounting course at Reykjavik University (Iceland). Prior to his position at West Virginia University, Dr. Dull's academic career has included teaching at Clemson University, Indiana University's Kelley School of Business-Indianapolis, and High Point University. He also served as a Fulbright Scholar at the University of Dubrovnik (Croatia).

Prior to academia, Dr. Dull worked as a computer programmer of accounting applications for a major manufacturing company. He then took those information systems experiences to public accounting where he worked as an auditor and systems consultant for a large CPA firm. Upon leaving that firm, he was the founding partner of a CPA/consulting firm where he assisted clients with the acquisition, installation, and support of enterprise systems as well as a variety of other information systems consulting areas.
