Artistic Transformation of the Works of Sh. Rashid Bin Khalifa Al Khalifa "An Analytical Study of the 1968 – 2013" Period

#### **Abstract:**

The aim of this research was to study and analyse the art works of the commendable Shaikh Rashid bin Khalifa Al Khalifa from the Kingdom of Bahrain. The study discussed the importance of the aesthetic values which the artist adopted throughout his career in contemporary plastic art; as well as, how he deployed his art as result of various foundations and experiences. Furthermore, the research analysis gives some concentration to the artist's effort to fill the apparent lack of academia in the study of the modern plastic art movement. In order to achieve the research objectives most correctly, an analytical approach was adopted and the research was divided into two main parts: the theoretical part in the first three chapters, and the analytical study of artistic works in chapters four and five.

Chapter one contains the introduction, previous studies examined, and the statement of the research problem and aims. While the second chapter shines light on the theoretical framework and splits into two main topics: the first topic being the contemporary plastic art movement in the entire Arab World; and, the second is more specific by investigating the contemporary plastic art movement only in the Arabian Gulf countries. Overall, the third chapter explores the role Sheikh Rashid bin Khalifa Al Khalifa played in the contemporary art movement of the Kingdom of Bahrain. This chapter is also divided into two sections: the first section highlights on the contemporary art movement within the Kingdom of Bahrain; whilst, the second half focuses on the artist himself, and his successful career as a leading Bahraini painter. Specific works of Sheikh Rashid bin Khalifa Al Khalifa's were chosen to reflect and express upon the various way in which he was influenced.

Part two of the research includes an analytical study of the artist's works, research procedures, and the analytical framework. When conducting comparative analytical criticism, art was sorted based on collection, classification, and information in chronological order. This method was determined to be the best to articulate the continuing evolution of the artist's works, and also reveal the visual which each of these chosen works contained. For precision, interviews were conducted with the artist himself, as well as with other Arab artists. Such interviews allowed opportunity to study the artist's original paintings and analyse tools used. Scientific observation, analytical descriptive logic, and informative presentation methods were enacted, information was documented using illustrations and comparison tables between paintings. Results are presented in chapter five. Ultimately, the results shed more light on the works of Sheikh Rashid bin Khalifa Al Khalifa, and give more indepth exposure of his efforts, materials, techniques and plastic values. Finally, recommendations and proposals are identified in the conclusion of the research.

## STUDENT RESEARCH GRADUATION PROJECTS

## College of Art & Design

Lulwah AlRumaihi, senior interior design student, completed a research project titled "Receiving Knowledge in Blooming Spaces" advised by Dr. Hadeel Regal. The project assessed whether a school building's interior affects the learning process. Lulwa was applied to redesigning a two story school building located in Juffair, Bahrain with different zones and spaces. The objective was to "design welcoming educational environment which simplifies the learning process by sharing fun resources and bringing life to the place." The research was divided into four chapters: the first chapter consisted of the statement, problem, facilities, study on interior trends of this type, historical background, and objectives. Chapter two contained three case studies of other schools to compare and contrast the project objectives. Chapter three dealt with the theoretical research was developed on the Montessori methodology, space analysis, vertical and horizontal limitations, furniture, color scheme, materials used, school interior lighting, school ergonomics, school safety and security, and school acoustics treatment. Chapter four, "programming" included the concept of design, bubble diagram, zoning, and building circulation, which led to the project conclusion. The final outcome of the project developed an interior design for a bright and satisfying school space which could positively impact learning.

# College of Business and Financial Sciences

Layla Althawadi, completed a collaborative research project with Dr. Hala Elias, Dr. Arpita Mehrotra, and Northern Municipality. research was based on qualitative and quantitate methods and concentrated on municipal budgeting within the Northern region of Bahrain. It was conducted using a two phase process. In phase one the municipality was analysed through assessment of functions, programs, problems with the current budgeting system, and who were the stakeholders; while the second phase concludes suggestive approaches which the municipality can adopt for budget enhancement. Layla is found the research limitations to be access of statistics, and a gap in research of this topic. Yet, she was able to overcome the gap with informative interviews with municipal officials, which were usually conducted via email and/or phone. When Layla was asked how she felt about the research topic she said, "When I got involved in the numbers it became interesting to know the budgeting for each program and I became enthusiastic to proceed in this research." The project was completed in May 2018 and was recognised as the best project of the semester from the Business and Financial Sciences College.

# College of Law

Amina Saleh, former law student, graduated in 2017, completed a research project titled, "Investment Arbitration and the Importability of Arbitrate Award" advised by Dr. Maria Casoria. The aim of the research was to elaborate on the settlement mechanisms of investment disputes. The research was divided into three chapters. Chapter one gave the introduction and an overview of dispute resolution systems with historical evolution the system and a glimpse into the systems religious roots, then methods were highlighted regarding alternative dispute resolution systems. The second chapter defined investment and investment agreements along with the legal criteria for an agreement and an investment. Then it explained the regulations and clauses of the investments through domestic, regional, and international rules of law. The third and final chapter stated the problem of investment arbitration, to summarize the problem Amina referenced a quote "winning the arbitration is winning the battles whereas successfully enforcing the final award is winning the war." The enigma in enforceability and the paradox of consent is mentioned in chapter explaining arbitrational awards can be breached when the domestic laws differ with the international laws. The conclusion gave remedies to breaches and defined the protection measures and investment treaties for cases in which the state refuses enforcement of the award. The topic has many depths, and exploring it in this project led Amina and Dr. Maria Casoria to further develop the research into a book in the up-coming future.

# **Bahrain Appoints Women as Director General of Two Municipalities**

The Supreme Council for Women celebrates after Bahrain appointed two Bahraini women, Shawqiya Ibrahim Humaidan and Lamia Yousef Al-Fadhala, as director general of the Capital Secretariat and the Northern Municipality. They are the first two women to hold such positions in the history of Bahrain. They will be responsible for promoting municipal work in two of the four governorates in the Kingdom of Bahrain.

The attainment of two women in senior administrative positions is the field of municipal work is an example of the continuing development and progression of women in the Kingdom of Bahrain, especially in acquiring leadership positions in public affairs. Currently the proportion of women in leadership and decision-making positions in the executive authority is at 40%. A statistic which includes ministers and women of the ministerial rank, undersecretaries, and assistant undersecretaries. Furthermore, women currently make up 15% of the legislative authority, and the judicial authority is witnessing an increasing qualitative presence of women.
