# The Institutional Impediments to the Application of International Law in Myanmar: A Case Study of the Heroin and Jade Trade

The presentation explained the institutional impediments to the application of international law in Myanmar using the jade and opium trade as case studies. The discussion focused on Kachin State and Shan State because each is sufficiently similar in their shared colonial and post-colonial experiences and each possess a valuable resource that is subject to intense competition and conflict: Kachin State is home to the most pristine and sought-after jade on the planet, and Shan State is the largest producer of opium poppy in Myanmar—and the second largest producer in the world. The presentation showed that international law can only address human rights issues arising out of the jade and heroin industries in so far as domestic political and economic institutions allow. Myanmar is unable to address the human rights abuses in either industry because the powerful elites in the Burmese military and other ethnic armed groups lack incentives to bring about institutional change because doing so would disrupt the political equilibrium and reduce their rent-seeking income flow. These two commodities—jade and opium production—sustain war economies and embolden powerful elites who benefit from the extractive institutions in place while allowing human rights violations, including the right to life, the right to health, and workers' rights, to persist unabated.

# The carrier exemption from his liability in the contract for the carriage of goods by sea in accordance with the Rotterdam convention 2009 and the Bahraini Maritime law

The transportation of goods is generally considered the paramount factor in the movement of fortunes. Maritime transport is the most forefront method for transport; thus, explaining the immense legislative importance for the organization of its rules, on both international and/or national levels. The contract of maritime carriage is the regulator for this form of transport of goods, it confirms the shipping carrier has an obligation to carry the goods from one port to another for a fee. Accordingly, international efforts have been made to unify the rules and provisions relating to this responsibility, considering the maritime transport process as a multi-lateral activity and in territories belonging to different countries. Furthermore, international conventions and national legislation have attempted to reconcile between two important considerations. Overall, this study aims to clarify the provisions of liability and the exemptions of the carrier in both the Bahraini legislation and Rotterdam convention 2009 through compare and contrast with other various conventions. The studied, divided into two analysis sections, has reached several remediation of the studied international conventions and national legislations, referring to and how they can achieve the required balance between the protection of shippers and encourage maritime transport projects. Besides, research concluded several important recommendations regarding the amendment of some provisions of Bahrain maritime law.

#### **Protection of Copyright and Neighboring Rights**

The TRIPS agreement came with the principle of priority for national treatment to be practically enforced to eliminate borders between member countries; expanded the range of protection through these principles to cover the citizens of non-member countries and residents in countries members in the agreement; and included a set of exceptions on these principles, which conform with providing unified protection for copyright and art protection in light of applying these exceptions. While the objective of TRIPS agreement was to enhance protection measures among member countries and apply its principles and objectives to internationally promote the value of intellectual property, as TRIPS included the headlines of protection of copyrights and neighboring rights, and enforcing these principles was enough to rule with practically marginalizing the legal value of these principles. It is obvious that TRIPS agreement committed all its member states to provide legal protection not less than that provided to its citizens, as the legislations of the member states included texts regarding these principles in light of the fast and continuous technological development of cloning methods, and the increased need for the continuation of cultural exchange among states. This agreement showed the importance of neighboring rights, besides to author's copyright for its importance in publishing author's production through performers, Audio-recording producers, Radio organizations, and provide full protection for these organizations. The agreement showed the mechanism of protection for authors of digital literature and art works in the advanced countries upon using these works in the developing countries through enforcing the principles of the agreement, in a way that guarantees the literature and financial rights of authors, and the need of developing countries for these digital works to develop and exchange cultures between the citizens of member states.

Employability of Women in Art & Design in The Kingdom of Bahrain; Opportunities and Challenges by: Ms. Khadija Saeed Ali

#### **Abstract:**

All over the world, employers want to hire graduates with the appropriate skill set for the job. In a global perspective, embedding employability in a creative curriculum is the integration of practice, behaviors and qualities to develop and sustain a rewarding profession or career. Thus, generating benefits for the new graduate and their communities.

Graduates, specifically in Art and Design disciplines, have clear intentions and desires to engage in enterprise by using their employability skills after graduation within the workplace. However, it should be well comprehended how much they really can offer as fresh graduates to the industry. Preparing students for employment in Art and Design incorporates explicit learning, teaching, and curriculum intended to incorporate employability as a prominent, inclusive and valued part of discipline practice. This research addressed the topic of Employability for Women in Art and Design in the Kingdom of Bahrain, which is an important issue to study in the dynamic market of the Kingdom of Bahrain for the Art and Design sector. University qualification is the key to many careers within the growing Art and Design market which emphasizes the significates of this research. The research also investigated how universities globally prepare their graduates for a career in Art and Design through review of literature, and observation of how local institutions prepare their graduates in an exceedingly competitive and highly skilled environment. Women Art and Design graduates in Bahrain face different challenges and issues when searching for a suitable job and place to succeed in their profession. The challenges women face in their career are addressed in this research. In addition, challenges are not the priority of choice in terms of putting them at work due to several identified factors which needed to be addressed to open opportunities and meet basic expectations of employers to employ recent

graduates and give them a platform to become competitive with others.

## Research in Progress - Graduation Projects

#### College of Art & Design

Zainab Ibrahim, interior design student, is focusing her senior project on the RUW Dorms. In order to conduct her research, she has divided the project into a three series. Step 1. Case study of 3 international dorms, located in Denmark, Chigo, and Cambridge to understand their design functions and in what ways they provoke student interaction. For step 2, Zainab created a survey for students living in the RUW dorms. Through this survey she questioned what they wish for from the dorms (colors, functions, etc.), what they enjoy, and what complaints they have. Stage 3 consisted of an interview with Director of Student Affairs, who oversees the dorms. For the conclusion, Zainab will provide design suggestions on ways to improve the dorm space, so it will have a "homier environment to attract more students to live in the dorms." She chose this topic because, "I am studying at RUW, so I wanted something dealing with my university to help encourage the women and spaces here." Her project advisor is Dr. Hadeel, however she is consulting all the CAD doctors for feedback on her project.

#### **College of Business & Financial Services**

**Layla Althawadi**, is working on a collaborative research project with Dr. Hala, Dr. Arpita, and the Northern Municipality. The research, based on qualitative and quantitate methods, concentrates on municipal budgeting within the Northern region of Bahrain. It is being conducted  $\,$ in a two phase process. In phase one the municipality is analyzed through assessment of functions, programs, problems with the current budgeting system, and who the stakeholders are; while the second phase concludes suggestive approaches which the municipality can adopt for budget enhancement. Layla is finding the research limitations to be, "a gap in research, and access to statistics." However, she is overcoming the gap through interviews with municipal officials, usually conducted via email and/or phone. When Layla was asked how she felt about the research topic she said, "When I got involved in the numbers it became interesting to know the budgeting for each program and I get enthusiastic to proceed in this research." The project will be completed in Spring 2018.

#### College of Law

Zainab Hassan, College of Law senior student, is currently working on completing her final year project titled "International Protection of Intellectual Property Rights and National Implementation in the Kingdom of Bahrain" supervised by Dr. Maria Casoria. She has divided her project into four chapters: 1. General overview of intellectual property, 2. International protection of intellectual property (IP) rights, 3. Protection of IP rights in Bahrain, and 4. Conclusion. She is passionate about her chosen topic and is excited to be at this stage in her studies. She stated, "This is my final challenge and I have to achieve it successfully." She decided upon this topic after taking the course "Law of Intellectual Property" with Dr. Maria Casoria where she found it to be interesting that these rights must be protected. Further on, Zainab passionately believes in her research and the necessity of examining it because, "people must be aware of how they can protect their rights that are intangible, and people need more knowledge on this matter." She will support her project by using mixed research methods, many various sources such as books, journals, websites, databases, opinions and legal articles. Upon completion, her project conclusion will provide recommendations for the Kingdom of Bahrain about ways to better implement these rights for its citizens.

#### IN THE REGION

## **Orange Campaign**

November 25 to December 10 the United Nations Information Centre (UNIC) and its partners launched the Orange Campaign, 16 Days of Activism against Gender-Based Violence. The campaign aimed to raise public awareness and mobilize people worldwide to bring forth change. The 2017 theme was "Leave no one behind: end violence against women and girls." UNIC Manama and partners observed the International Day to End Violence against Women and Girls on November 25 at the A'ali Mall (Gate No. 2). UNIC Manama called upon all of its partners within the area to participate in the United Nations Global Orange Campaign aiming "to reach out to the most undeserved and marginalized including refugees, migrants, minorities, indigenous peoples and populations" afflicted by conflict and disaster. UN Secretary General, Antonio Guterres stated that, in order to effectively fulfill the 2030 Agenda for Sustainable Development of reaching the fulfillment of human rights, women's inclusion and participation in sustaining peace, then collective action must be taken to end major barriers such as violence, harassment and harmful practices against women.

# Plans to Increase Percentage of Women in Local Trade Unions

In Bahrain News, the General Federation of Bahrain Trade Union (GFBTU) leads a campaign to increase the percentage of women representation of local trade unions over the next 3 years. The target percentage of women representatives is 30, while currently 12% of women representation is held in sectors of mixed male and female employees, and 25% represent in sectors with higher female employees. In hopes to achieve the target goal of 30%, efforts will be mostly concentrated on sectors where women employees are more such as kindergarten teachers and retail industries. Initiatives are being executed, for example, a workshop held on November 27<sup>th</sup> to train and encourage women to pursue trade union leadership roles. Overall, this is another step towards the Kingdom of Bahrain's vision to empower women in all fields.

### **Exposure of Bahrain Initiatives Abroad**

On November 12-14, Shaikha Rana bint Isa Al Khalifa, Bahrain Undersecretary of the Ministry of Foreign Affairs, Kingdom of Bahrain, visited Japan on a working visit. There she met with Noriyuki Koda, Japan's Undersecretary of the Gender Equality Bureau. In their meeting Shaikha Rana bint Isa Al Khalifa stressed the importance placed by the Kingdom of Bahrain on the empowerment of Bahraini women at all levels. Noting achievements such as the establishment of Her Royal Highness Princess Sabeeka bint Ibrahim Al Khalifa Award for Empowering Women. The Japanese Undersecretary was pleased to hear of these progressions and praised them. Overall the visit further developed friendly relations between Bahrain and Japan.

### ARAB WOMEN OF THE YEAR AWARDS 2017

The third edition of the Arab Women of the Year Awards took place in London, November 30<sup>th</sup>. The prestigious global celebration of achievement and excellence for Arab women from around the world honored some exceptional Arab women involved in all types of pioneering work. Among them was Bahrain's **Shaikha Hind Bint Salman Al-Khalifa** receiving **Achievement in Trade Development Award.** She has been involved in business activities in different economic areas and is the Director of the Bahrain Chamber of Commerce & Industry. The Bahraini royal, President of the International Federation for Bahraini Business & Professional Women, is further known for her numerous community related achievements. The high-profile awards ceremony, toasted outstanding women who have left a positive mark in different fields, regionally and internationally, and have contributed immensely to public life.

# RUW 2<sup>nd</sup> Women and Society Conference The 8<sup>th</sup> Annual Gulf Education Conference Empowering Women through Higher Education (18-19 April 2018)

RUW continues with its bi-annual Women and Society conference which initially began in April 2016. In April 2018 RUW will host its 2<sup>nd</sup> conference in collaboration with Gulf Conferences LTD., a U.K. based event coordinating company with specialisation in Higher Education. The conference organising committee is currently working on finalising all brochures and documents. #### **About the Conference:**

Women are contributors to the nation building, economic sector and the community life; however, throughout the world women are under-represented in the majority of employment sectors. Most often, women are paid less than men and have fewer opportunities to reach top positions. The gender gap is not only a misfortune to women themselves; economies, communities and families also endure burden from this inequality. Education is one of the most significant factors towards the progression and advancement of women. Nevertheless, higher education institutions must increase their efforts to enhance further developments.
